

The energy transition environment The broader context – playground for innovation

EU Clean Energy Package 2018-2019

- Energy storage included for the first time
- Commercial focus covered by TSO/DSO unbundling rules
- Domestic implementation underway

Network Codes – a new level of stability

- Applied since 2015
- · Harmonised rules in all key areas
- Don't cover storage yet but flexible to allow action at national level




Pivotal role – sustainable energy transition


- Optimising cost of transmission infrastructure
- Optimising cost of system operations
- New revenue streams for intermittent RES
- Complimentary to the hydrogen strategy

EU Innovation Fund

- new grant scheme running from 2020 until 2030
- distribution of approximately €10 billion towards low-carbon projects
- energy storage one of four focus areas
- first call for smaller scale projects now open

The Energy Law

- Concepts of distributed energy projects and cooperation developed since 2011
- Harmonized approach to energy storage underway

National Implementation Plan

- Reviewed by the EC, updated May 2020
- Energy storage directly recognised
- Multi-level dependencies recognised (e.g. metering, capacity market, new revenue streams on the balancing market)




New Balancing Market Conditions

- Approved on 1 December 2020
- Applying from 1 January 2021
- Energy storage gains direct access to the Balancing Market and system services

Next to come

- Updated prosumer and energy community regulations
- Including storage based hybrid RES installations in the CfD support scheme
- Improved revenue streams on the Balancing Market (from 2022)
